From time to time he finds something which he can make me do. On this occasion he has pointed out that he needs a valedictory for the spring newsletter. NOMINEE FOR PRESIDENT

The Secretary-Treasurer has received valid nominating petitions for one candidate for the office of president, Eugene N. Borza, Professor of Ancient History at The Pennsylvania State University. Professor Borza was educated at Baldwin-Wallace College and the University of Chicago. Professor Borza's numerous publications primarily concern vanious aspects of Macedonian history and include in addition to almost two dozen articles in various scholarly journals The Impact of Alexander the Great, Macedonia and Greece in Late Classical and Early Hellenistic Times, Philip II, Alexander the Great and the Macedonian Heritage and a new edition of U. Wilcken, Alexander the Great. Professor Borza is a member of numerous learned societies and the recipient of research grants from, among others, the American Philosophical Society and the NEH and ACLS. In addition, he plays the trumpet in a dance band and contributes a wine column to a local newspaper.

CALL FOR PAPERS

The 1985 meeting of the AAH will be held on the campus of the University of Pittsburgh on May 2-4. Three panels are planned on the following topics: (1) the family; (2) the independence of topics: (1) the family; (2) the independence of states; and (3) land-use. Each topic embraces all of Greek and Roman antiquity; and in selecting papers for inclusion in the panels an effort will be made to achieve broad representation. panel will comprise two or three papers on all of which a single respondent will comment. Thus far invitations have been extended to, and accepted by, Martin Ostwald for the independence panel and Michael Jameson for the land-use panel. Submissions are herewith solicited on all three Michael Jameson for the land-use topics. Abstracts should be lengthy and detailed enough to provide a good idea of the scope, argumentation, and evidential basis for the paper. Since they will be judged anonymously, submissions should be accompanied by a cover letter but otherwise not reveal the identity of the author. - Professor C.G. Starr moved approval of the minutes of the 1982 meeting. MSP
- 2. President Treggiari presented the President's report. She requested that members forward to her their ideas on the conduct of the Association's affairs and the direction it should take. She also reported on her correspondence with Prof. J. McCredie concerning possible conflicts between meetings of the AAH and the managing committee of the American School of Classical Studies. Finally, President Treggiari requested that members keep the officers informed concerning plans for possible sessions at future meetings of the AHA.


