PRESIDENT'S CORNER

Dear Colleagues,

"Beholden" is an ancient word well fitted to convey my gratitude, on your behalf, to all those who responded so generously to create a subvention fund to assist beginning scholars to attend the annual meeting. Many, still anonymous, colleagues pursuing the association's goal of furthering the understanding of the deep past, will be truly beholden.

The response means that we can begin funding this year. Details are given separately (p. 4). However, we have NOT YET achieved the target. According to my reckoning, if every current member who has not yet made a donation were to give just \$7.00, the goal would become an accomplished fact.

I'll push a bit harder. Our vital, fascinating field is endangered. Some of our own colleagues in departments of history loudly debate the value of replacing a retiring historian of the ancient world when they could add instead to more current, thus "important" fields of historical inquiry. Every year I write several letters in support of programs threatened with severe cuts or complete termination; those letters fly to Australia, Europe, Canada and many parts of the United States. Below my signature, I add "current president of the Association of Ancient Historians" for there is strength in numbers brought together by common intent.

The subvention fund will continue, even enlarge, our solidarity into the future. Our annual meeting--exceptional among professional meetings, I think--is an ideal time to introduce future colleagues to our enterprise.

SPRING MEETING PLANS

The Association of Ancient Historians will hold its annual Spring Meeting at the University of Illinois, Urbana-Champaign.

Accommodations and meals will be provided at the Allerton Mansion Conference Center and at the Best Western in nearby Monticello, IL.



The meeting will begin with registration and an evening reception on Thursday, April 30. Four paper

sessions are planned, two on Friday and two on Saturday. The annual banquet will be on Friday evening. For those choosing to stay over Saturday night, entertainment will be provided Saturday evening and brunch will be provided on Sunday morning.

ATTENTION, YOUNGER SCHOLARS: A special session is planned for graduate students and those who have recently received the PhD to present papers. Papers should be limited to about 15 minutes and topics are open. *Please submit proposals to Dr. Mitchell at the address below.*

- 2. Great families, great houses, great gardens, great wealth
- 3 Asia Minor (organized by John Eadie)



REPORT ON THE ELECTRONIC RESOURCES SURVEY

At the annual meeting last May the members were surveyed to determine their preferences in electronic resources usage and how the Association might better help them with their information needs. While the sample size was small (40 responses), the information collected still provides some information that can likely be generalized to the rest of the membership.

In terms of current usage, the survey respondents are overwhelmingly using the new electronic resources. Almost all (38 of 40) indicate that they have email. About 75% of them use their computers to browse the World Wide Web. Of that 75%, about 50% are regular users of the Web, logging on 4 or more times a week. 16% are light users (1-3 times a week), and 34% are occasional users (1-3 times/month).

Some possible uses of the Web were surveyed. Members showed a strong interest in beginning an Ancient History discussion group (88% of respondent indicated an interest).

The idea of receiving the AAH Newsletter electronically generated more mixed reviews: only 36% thought that an e-mail version of the newsletter would adequately replace the paper copy, while 37% thought that a Web version of the newsletter would be able to replace the paper copy. The costs of putting the newsletter out either via email or via the Web (comprised of the costs of creating and maintaining an electronic version and the need to create separate electronic and paper mailing lists) would probably not be repaid by the savings in postage.

When asked what they would like to

OPPORTUNITIES IN NUMISMATICS

The American Numismatic Society announces a variety of study and fellowship opportunities.

The 46th Graduate Seminar in Numismatics (June 17-August 15, 1998). Designed to familiarize students with numismatic methodology and scholarship, this seminar is an intensive program of study including lectures and conferences by specialists, preparation and oral delivery of a paper on a topic of the student's choice, and actual contact with related coinages. Applications accepted from students with at least one year of graduate work in classical studies, history, economic history, or related disciplines and from junior faculty with an advanced degree in one of these fields. Stipend of \$2000 available to citizens or permanent residents of the U.S. and Canada. **ANS Graduate Fellowship**. \$3500 awarded to a graduate student in humanities or social science who has attended an earlier ANS Graduate Seminar and who has completed the doctoral general examinations and is writing a dissertation during the academic year 1998/9 on a topic in which numismatics plays a significant part. Frances M. Schwartz Fellowship to support the study of numismatic and museum methodology at the ANS. Applicants must hold the BA or equivalent. Stipend varies with term of tenure (normally an academic year), not to exceed \$2000. Donald Groves Fund to promote publication in the field of early American numismatics (material no later than 1800). Funding is available for travel, research,

and publication costs. **Fellowship in Roman Studies** provides a fellowship of up to \$5000 to promote the use of ANS collections and library in connection with studies of the Roman world. The fellowship supports extended residence in New York and work in the Society's cabinet and library in support of a substantive research project. Applicants must be U.S. citizens or affiliated with a North American institution of higher learning, demonstrate academic competence, and submit a detailed proposal. This work may or may not be in pursuit of a higher degree; preference is given to those seeking advanced degrees.

Information and application forms for all of the above are available from the American Numismatic Society, Broadway at 155th Street, New York, NY 10032. All applications are due **March 1, 1998**.

Charles Hamilton, Professor of Ancient History and Classics at San Diego State University, wishes to arrange an exchange with a colleague at an institution in the Northeast, preferably in southern New England (but a wider geographical scope is possible) for the academic year 1998-99 or subsequent years. SDSU has an arrangement whereby a faculty member teaches at a host institution while receiving salary, benefits, etc. from the home institution. Many other institutions have similar options. SDSU is on a 15 week long semester system (AY 1998-99 approx. Sept. 1, 1998 to May 30, 1999; 5 week break Dec.-Jan.) and the teaching load is three 3-unit courses per term.
