# President's Column

Dear Colleagues,

Another matter that needs your attention is the **donation from Gene Borza's estate**. A huge fan of the AAH and having been there for it since its foundation, as you know, Gene left us \$5,000.00 in his estate, for which we are extremely grateful. The money has been deposited into our checking account already. In consultation with his wife, Kathleen Pavelko, and several former officers, it was decided that a wonderful way to honor Gene in the Association would be the creation of a subvention for assistance with publications (fees for permits or pictures, funds for indexer, illustrator, etc.). **I am bringing to you, therefore, a proposal to create the Eugene Borza Publications Subvention for the AAH**. This proposal, having fulfilled articles 13 and 14 of our constitution, will be included as a motion in the business agenda at the Annual Meeting. If 2/3 of the members at the meeting agree to this motion, then we will use the Borza donation as seed money for the creation of the new subvention and fundraise for more. The Treasurer, Scott Perry, will set up a (separate?) account for it, in a format similar to the Travel Subvention we already have. Another suggestion is that we can put all the monies raised for both subventions in the Vanguard account, and draw predetermined percentages for both subventions from it. The latter will be easier and faster to accomplish. The Subvention Committee will be charged with the task to draw guidelines for the new subvention and it will choose the recipients according to those guidelines.

Last, but not least, I am putting out a call for volunteers for our different committees. I know that we are all doing very much already for our students, families, departments, and universities; and we are all exhausted. For most of us (I know this is true for me, at least), the AAH has stood by us since the days we were graduate students: we presented papers, received travel subventions, met the profession's "stars," networked, and landed jobs, made friendships, and put together our next project. The AAH has always been a supportive and congenial group. Serving on one of our committees is an easy way to give back to our Association so it can continue to serve the next generation of ancient historians. ## EMPLOYMENT OPPORTUNITY

The Honors program at Loyola University of Chicago is in need of a part-time instructor to teach within a team-taught freshman course on the Western Tradition (loosely defined), in-person in the Fall of 2022. Historically, we have had a classicist provide lectures on Virgil, Homer, Ovid, or Greek tragedy. The instructor of Classics would be responsible for lecturing to the entire freshman class (of approximately 350 students) on 2-3 texts, and then they would lead a discussion group of 20-25 students three times a week for the entire Fall semester, in which they would lead discussions on all the texts on the syllabus. The course counts as 6 credit hours. There is great possibility for continuation in the program

In Memoriam: Eugene N. Borza, 1935-2021

Eugene (Gene) N. Borza, who died September 5<sup>th</sup>, 2021, was a founding member of the Association of Ancient Historians at its birth in May 1969 at McMaster University. Even before we had officers, he organized the fourth annual meeting, at Penn State, in 1972. Gene went on to serve two terms as president (1984-1989), and he, along with his wife Kathleen, were a familiar sight at annual gatherings until illness made his attendance impossible. His festschrift, *Macedonian Legacies*, was presented at the AAH business meeting in 2009, complete with a formal Honoring.

Gene was a native of Cleveland, Ohio, the child of Romanian immigrants. After receiving a BA from Baldwin Wallace College in 1957, he taught high school for a few years before entering the graduate program at the University of Chicago, where he studied under Stewart Irwin Oost, who directed his PhD thesis on Diodoros's Book 17. He would go on to become a leading voice not only in scholarship of Philip II and Alexander the Great, but also took the vanguard of an emerging field: Macedonian Studies itself, or "Macedoniasts," as his friend Ernst Badian dubbed them.

Gene was hired by Penn State in 1964, where he taught in the history department until his retirement in 1995. During that time, he published more than 50 peer-reviewed articles (and dozens more in non-academic papers, journals, and magazines), as well as his groundbreaking *In the Shadow of Olympus* (1990, rev. 1991) from Princeton Univ. Press, on pre-Alexander Macedon, also *Before Alexander: Constructing Early Macedonia*, and a number of edited collections. He served as an AIA lecturer for 40 years, and was an invited visiting professor at five colleges and universities beyond PSU. In 1981, he was a historical advisor to the National Gallery of Art's groundbreaking exhibition, *The Search for Alexander*.

He is survived by his wife of 46 years, Kathleen Pavelko, as well as his daughter, Dr. Karen Borza Arabas, his son Michael John Borza, and his granddaughter, Julia Arabas. A celebration of his life will be held in late July; the program and a video of his life will be made available.
